	Salem Township/Salem North & Salem South (exclusive of City of Urbana)	An additional tax for the benefit of Salem Township (exclusive of the City of Urbana) for the purpose of general construction, reconstruction, resurfacing and repair of roads at a rate not exceeding 2.9 mills for each one dollar of valuation, which amounts to \$0.29 for each one hundred dollars of valuation, for 5 years, commencing in 2016, first due in calendar year 2017.
	Northwestern Local School District/Part of Mad River A & Urbana South (filed in Clark Co)	Shall a tax levy substituting for an existing levy be imposed by the Northwestern Local School District for the purpose of providing for the necessary requirements of the school district in the initial sum of \$1,692,850, and a levy of taxes be made outside of the ten-mill limitation estimated by the county auditor to require 7.32 mills for each one dollar of valuation, which amounts to \$0.732 for each one hundred dollars of valuation for the initial year of the tax, for a period of 5 years, commencing in 2016, first due in calendar year 2017, with the sum of such tax to increase only if and as new land or real property improvements not previously taxed by the school district are added to its tax list?

	West Liberty-Salem Local School District/Concord, Harrison, Salem North, Salem South, Union North, Wayne (filed in Logan Co)	Shall an annual income tax of one percent (1%) on the school district income of individuals and of estates be imposed by the West Liberty-Salem Local School District to renew an income tax expiring at the end of 2016, for three (3) years, beginning January 1, 2017, for the purpose of current expenses?
